The undersigned hereby acknowledges, understands and agrees that this is a waiver of rights to bring any claim or action against World Baseball Showcases, Steve Fish, his administrators, officers, directors, agents, managers, coaches and other volunteers and employees, other participants, sponsoring agencies, sponsors, advertisers, and owners and lessors of premises used to conduct the event. The undersigned hereby knowingly and voluntarily acknowledges, understands and agrees that any and all disputes, controversies and claims of any kind arising out of or relating to this waiver or the rights and obligations of the parties shall be determined and settled solely by final and binding arbitration to be conducted by the American Arbitration Association in accordance with an Arbitration Act (in any particular state). The undersigned acknowledges, understands and agrees that he/she is expressly, knowingly and voluntarily agreeing to irrevocably waive his/her respective rights to have any and all disputes, controversies or claims concerning this waiver determined by a jury trial or other civil trial.

I HAVE READ THIS WAIVER, RELEASE OF LIABILITY AND ASSUMPTION OF RISK AGREEMENT BEFORE SIGNING, AND I FULLY UNDERSTAND ITS TERMS, UNDERSTAND THAT I HAVE GIVEN UP SUBSTANTIAL RIGHTS BY AGREEING TO IT ON MY OWN BEHALF OR ON BEHALF OF MY SPOUSE AND CHILD/WARD, AND I SIGN IT FREELY AND VOLUNTARILY WITHOUT ANY INDUCEMENT.
